      - 1. NE Lightning only has 6 players as of now, at the most 8 players
      - 2. Will count NE Lightning out as a backup plan
    - ii. Let Niki and Kay know by Tuesday 6/7 so they can rework schedule if needed- Niki will send out any updates that are made
  - c. Copa del Sol Tournament Update
    - i. As of now, no teams have signed up
    - ii. People may be concerned with playing full 11v11 games in the middle of July

- iii. Likely not possible to restructure the brackets due to a lack of timewill likely have to cancel. Will wait until June 12<sup>th</sup> deadline to officially cancel
